1. The Violence Against Women Reauthorization Act of 2013

Sponsored by Senator Leahy (D-VT), the House's reauthorization of the Violence Against Women Act (S. 47) creates a slush fund for progressive groups purporting to help women and their families in abusive situations. The bill discourages intactness by deprioritizing counseling and failing to recognize mutual partner abuse. Other problems include the extension of Indian tribal jurisdiction over non-tribal citizens, an increase in the number of available immigration visas past annual caps and the authorization of new grants despite a documented history of abuse.

(Passed 2/28/2013, 286 yeas to 138 nays, Roll Call No. 55)

FRC Opposed this Bill.

2. The 2013 Pain-Capable Unborn Child Protection Act

Offered by Rep. Trent Franks (R-AZ), the Pain-Capable Unborn Child Protection Act (H.R. 1797) would nationally prohibit abortion after 20 weeks gestation, the point at which an unborn baby possesses the ability to experience pain.

(Passed 6/18/2013, 228 yeas to 196 nays, Roll Call No. 251)

FRC Supported this Bill.

3. Preventing Atheist "Chaplains"

Offered by Rep. John Fleming (R-LA), Amendment #35 to the Department of Defense Appropriations Act would ensure the Defense Department (DoD) follows its own rules in the appointment of chaplains by requiring candidates to have the endorsement of a qualified religious organization. This amendment came as a response to DoD's consideration of appointing non-religious, atheist "chaplains."

(Passed 7/23/2013, 253 yeas to 173 nays, Roll Call No. 392)

FRC Supported this Amendment.

4. Health Care Law Delay and Conscience Protections

Offered by Rep. Marsha Blackburn (R-TN), amendment #2 to the continuing resolution (H.J. Res. 59) would have delayed implementation of the Health Care Law (P.L. 111-148) by one year and provide conscience protections.

(Passed 9/29/2013, 231 yeas to 192 nays, Roll Call No. 498)

FRC Supported this Amendment.

5. No Taxpayer Funding for Abortion Act

Offered by Rep. Chris Smith (R-NJ) and Dan Lipinski (D-IL), the "No Taxpayer Funding for Abortion Act" (H.R. 7) would permanently codify the Hyde Amendment across government programs by preventing federal funds from paying for abortion and health care plans that include abortion.

(Passed 1/28/2014, 227 yeas to 188 nays, Roll Call No. 30)

FRC Action Supported and Scored this Bill.

6. Allowing Veterans Affairs Providers to Recommend Marijuana as Medicine

Offered by Rep. Earl Blumenauer (D-OR), this amendment would use the Military Construction and Veterans Affairs Appropriations Act (H.R. 4486) as a vehicle to make an end run around the Federal government's longstanding rejection of marijuana as medicine.

(Failed 4/30/2014, 195 yeas to 222 nays, Roll Call No. 186)

FRC Action Opposed and Reserved the Right to Score

7. Preventing the Department of Justice from Enforcing Federal Marijuana Laws

Offered by Rep. Dana Rohrabacher (R-CA), this amendment (H.Amdt. 748) to H.R. 4660 the Commerce, Justice, Science and Related Agencies Appropriations Act (CJS) would restrict the Department of Justice from enforcing the Controlled Substances Act (CSA) which makes it illegal to manufacture, distribute, dispense or possess marijuana, even for purported medical use in states where it is legal.

(Passed 5/30/2014, 219 yeas to 189 nays, Roll Call No. 258)

FRC Action Opposed and Reserved the Right to Score this Amendment.

8. Preventing the Relaxation of Banking Restrictions on Marijuana Transactions

Offered by Rep. John Fleming (R-LA), this amendment (Amendment No. 1) to H.R. 5016, the Financial Services and General Government Appropriations Bill for FY 2015 would prevent the Department of Treasury from implementing guidance relaxing bank reporting requirements for suspicious activities involving proceeds from marijuana transactions.

(Failed 7/16/2014, 186 yeas to 236 nays, Roll Call No. 415)

FRC Action Supported this Amendment and Reserved the Right to Score

SENATE

1. The Violence Against Women Reauthorization Act of 2013

Sponsored by Senator Leahy (D-VT), the House's reauthorization of the Violence Against Women Act (S. 47) extended Indian tribal jurisdiction over non-tribal citizens, increased the number of available immigration visas past annual caps and authorized new grants without addressing a documented history of abuse. The bill, while purporting to help couples and their families, discouraged intactness by discouraging counseling and failing to recognize mutual partner abuse.

(Passed 2/12/13, 78 yeas to 22 nays, Roll Call No. 19)

FRC Opposed the Bill.

2. On the Nomination of William Kayatta

Nominated by President Obama to serve on the U.S. First Circuit Court of Appeals, Mr. Kayatta argued for changes to the current judicial practices of election, retention and compensation that would have abetted activist judges and promoted institutional elitism. There is substantial evidence that Mr. Kayatta would have set his personal views over and above the Constitution.

(Confirmed 2/13/2013, 88 yeas to 12 nays, Roll Call No. 20)

FRC Opposed Confirmation.

3. Cloture on Caitlin Halligan Nomination

Nominated by President Obama to the District of Columbia Circuit Court, Ms. Halligan, while acting as New York's Solicitor General, made appeals to an evolving Constitution to attack traditional marriage and the lawful activities of pro-life organizations. Evidence suggested Ms. Halligan would have placed her vision of society ahead of the Constitution.

(Failed 3/16/2013, 51 yeas to 41 nays, Roll Call No. 30)

FRC Opposed Confirmation.

4. Expressing the Sense of the Senate to Enact the Child Interstate Abortion Notification Act

Offered by Sen. Marco Rubio (R-FL), this measure would have signaled the Senate's desire to enact the Child Interstate Abortion Notification Act (CIANA, S. 369). This amendment would have made it a federal offense to transport minors across state lines to obtain an abortion in order to avoid a parental involvement law in the minor's home state. The bill would have also required an abortionist in a state with no parental notice law to notify the parents of an out of state minor at least twenty-four hours before performing an abortion.

(Failed 3/22/2013, 48 yeas to 51 nays, Roll Call No. 64)

FRC Supported this Motion.

5. Restoring Health Care Law Funding

Offered by Senate Majority Leader Harry Reid (D-NV) to the Continuing Appropriations Resolution of 2014 (H.J.Res. 59), this amendment (S.AMDT. 1974) restored funding to the Healthcare Law (P.L. 111-148) after being defunded in the House. The Health Care Law allows funding for abortion, rations care and undermines conscience protections.

(Passed 9/27/2013, 54 yeas to 44 nays, Roll Call No. 208)

FRC Opposed this Amendment.

6. Striking Health Care Delay and Conscience Protections

Offered by Senate Majority Leader Harry Reid (D-NV), this vote tabled the House passed provisions attached to the Continuing Appropriations Resolution of 2014 (H.J.Res. 59) that would have delayed the Health Care Law and provide conscience protections

(Passed 9/30/2013, 54 yeas to 46 nays, Roll Call No. 210)

FRC Opposed this Measure.

7. The Employment Non-Discrimination Act of 2013

Offered by Sen. Jeff Merkley (D-OR), the Employment Non-Discrimination Act of 2013 (ENDA, S.815) would have expanded employment discrimination law to include subjective characteristics related to an individual's perceived "sexual orientation" or "gender identity." Despite efforts to amend ENDA with a narrow religious exemption, the bill as passed unnecessarily burdens the vast majority of employers' and employees' constitutional freedoms of religion, speech and association.

(Passed 11/7/2013, 64 yeas to 32 nays, Roll Call No. 232)

FRC Opposed the Bill.

8. Cloture on Cornelia Pillard Nomination

Cornelia Pillard was nominated by President Obama to serve as a U.S. Circuit Judge for the District of Columbia Circuit Court. This procedural motion required 60 votes to proceed to nomination. Ms. Pillard's academic writings and arguments in court indicate she is a "reproductive rights" ideologue who views abstinence-only education, limitations on abortion access and conscience protections for religious employers as unconstitutional violations of the equal protection clause. She is therefore unfit for a lifetime appointment to the appeals court.

(Failed 11/12/2013, 56 yeas to 41 nays, Roll Call No. 233)

FRC opposed this Cloture Vote.

9. Nomination of Chai Feldblum

Chai Feldblum was nominated by President Obama to serve as a Member of the Equal Employment Opportunity Commission. Ms. Feldblum is a long-time liberal activist who admitted to "having a hard time coming up with any case in which religious liberty should win" when in conflict with sexual expression. There is evidence Ms. Feldblum would use her position on the Commission to advance her ideologies.

(Passed 12/12/2013, 54 yeas to 41 nays, Roll Call No. 258)

FRC opposed this Nomination.

10. Cloture on Pamela Harris

Nominated by President Obama to the United States Court of Appeals for the Fourth Circuit. Professor Harris has described the Constitution as "a profoundly progressive document" that she claims even the activist Warren Court was too conservative to fully appreciate. These and other radical judicial notions, such as her views on abortion, cast serious doubt on whether Harris could faithfully and impartially apply the law and precedents to a case free from her preconceived notions.

(Invoked 7/24/14, 54 yeas to 41 nays, Roll Call No. 241)

FRC Action Opposed Nomination

11. On the Nomination of Michelle Friedland

Nominated by President Obama to serve on the United States Circuit Court of Appeals for the Ninth Circuit, Friedland's legal writing and arguments to the court indicate her willingness to use the judiciary to usurp legislative power. She has treated Constitutional Amendments that run contrary to her agenda as statutes and has shockingly claimed that the Constitution only creates rights to the extent a judiciary says it does.

(Confirmed 4/28/2014, 51 yeas to 40 nays, Roll Call No. 108)

FRC Action Opposed Nomination.

12. On the Nomination of David Barron

Nominated by President Obama to the United States Court of Appeals for the First Circuit, Professor Barron has been an outspoken advocate of judicial activism and has praised the use of the courts in advancing progressive policy prescriptions in advance of legislatures and popular will.

(Confirmed 5/22/2014, 53 yeas to 45 nays, Roll Call No. 162)

FRC Action Opposed this Nomination.

13. Cloture on the Protect Women's Health from Corporate Interference Act

Offered by Sen. Patty Murray (D-WA), the Protect Women's Health from Corporate Interference Act (S.2578), would force family businesses, like Hobby Lobby and Conestoga Wood Specialties to violate their deeply held beliefs, and provide drugs and services to their employees in their healthcare plan, to which they object, or face crippling fines.

(Failed 7/16/2014, 56 yeas to 43 nays, Roll Call No. 228)

FRC Action Opposed Invoking Cloture.

14. Cloture on the Constitutional Amendment Restricting Political Speech

Offered by Sen. Tom Udall (D-NM), this amendment to the Constitution (S.J. Res. 19) would have limited the First Amendment right of Americans to fully engage in their representative democracy. As proposed, S.J. Res. 19 would empower lawmakers to place new sanctions, whether financial or criminal, on "contributions and expenditures intended to affect elections" for the alleged purpose of advancing equality in the electoral process.

(Failed 9/11/2014, 54 yeas to 42 nays, Roll Call No. 261)
