Dear Voter and Friend of the Family,

FRC Action presents our Vote Scorecard for 2020, the Second Session of the 116th Congress. This scorecard contains a compilation of significant votes on federal legislation affecting faith, family, and freedom that FRC Action either supported or opposed. These recorded votes span the 2020 calendar year.

In the U.S. Senate, FRC Action scored in favor of two key pro-life bills. First, the *Pain-Capable Unborn Child Protection Act*, which would prohibit elective abortion after 20 weeks gestation (when an unborn baby can feel pain). Second, the *Born-Alive Abortion Survivors Protection Act*, which would require health care practitioners to provide life-saving medical care to babies born alive after an attempted abortion. Unfortunately, both bills failed to pass.

FRC Action also scored in favor of two nominations. First, the nomination of Russ Vought to be director of the White House Office of Management and Budget. Mr. Vought is a solid pro-life and pro-family conservative who was instrumental in enforcing the Protecting Life in Global Health Assistance policy, enacting conscience protections for health care professionals, and clarifying the definition of sex discrimination in the Affordable Care Act to ensure that biological science remains the cornerstone of the medical profession. Second, the nomination of Amy Coney Barrett to be an associate justice on the U.S. Supreme Court. Barrett is known to be a dedicated originalist who interprets the law as written, not to achieve certain policy outcomes.

In the U.S. House of Representatives, FRC Action supported a discharge petition that—were it to receive the support of a majority of House members—could force House leadership to hold a vote on the *Born-Alive Abortion Survivors Protection Act*. Unfortunately, only 203 of the necessary 218 members signed the petition. Additionally, FRC Action opposed efforts in the House to use coronavirus relief legislation as a vehicle for forcing through policies that negatively impact life, family, and religious liberty. FRC Action also opposed efforts to legalize marijuana and prevent the U.S. Department of Justice from enforcing existing marijuana laws.

For the first time ever, FRC Action decided to score against co-sponsorships of a bill. Despite its pleasant-sounding name, *Fairness for All* is merely a watered-down version of the similarly misnamed *Equality Act*—one that originated from the Republican side of the aisle. The only difference between the *Equality Act* and *Fairness for All* lies in the degree of harm they would cause if passed. While *Fairness for All* does include some attempts to preserve religious liberty for religious institutions, it leaves the rights of individuals unprotected. We scored against co-sponsorship to ensure pro-religious liberty members of Congress understood the dangers of this bill.

This vote scorecard contains 15 actions in the House—including 13 votes, one bill co-sponsorship, and one discharge petition—and five votes in the Senate for the Second Session of the 116th Congress. Although the House successfully passed some anti-life, anti-family, and anti-religious liberty pieces of legislation last year, thankfully, the Senate declined to bring many of them to the floor.

Much still needs to be done legislatively to rebuild a culture in which all human life is valued, families flourish, and religious liberty thrives. Thank you for standing with us!

116th Congress 2nd Session Scorecard Summaries

HOUSE

1. Motion to Recommit Acknowledging Unborn Children as a Vulnerable Population

Offered by Rep. Cathy McMorris Rodgers (R-WA), the Motion to Recommit sought to amend the *PFAS Action Act of 2019* (H.R. 535) to include unborn children in the list of vulnerable populations to be considered when developing drinking water standards. Including this language acknowledges the fact that clean drinking water for pregnant women also affects their unborn children.

(Failed 01/10/2020, 187 yeas to 219 nays, Roll Call No. 12)

2. Removing the Deadline for the Ratification of the Equal Rights Amendment

Sponsored by Rep. Jackie Speier (D-CA), this resolution (H.J.Res.79) sought to remove the Equal Rights Amendment (ERA) ratification deadline. If ratified, the ERA would remove existing abortion regulations and force taxpayer funding for abortion. It could also roll back women's civil rights protections. Even with a resolution to remove the ratification deadline, the Department of Justice has said the current ERA is dead, and the process to ratify the amendment would need to start over.

(Passed 02/13/2020, 232 yeas to 183 nays, Roll Call No. 70)

3. Motion to Recommit Adding the Born-Alive Abortion Survivors Protection Act

Offered by Rep. Greg Walden (R-OR), the Motion to Recommit sought to include the entire language of the *Born-Alive Abortion Survivors Protection Act* (H.R. 962) as an amendment to the *Reversing the Youth Tobacco Epidemic Act of 2019* (H.R. 2339). This language would require health care practitioners to provide the same medical care to infants born alive after a failed abortion as they would to any other infant born at the same gestational age. It would also create criminal penalties to enforce what is currently only a definitional provision in federal law.

(Failed 02/28/2020, 187 yeas to 220 nays, Roll Call No. 77)

4. The Heroes Act

Sponsored by Rep. Nita Lowey (R-NY), the partisan coronavirus relief bill, *The Heroes Act* (H.R. 6800) attempted to advance policies that negatively impact life, family, and religious freedom. This bill would provide large amounts of funding without pro-life protections, redefine sex to include sexual orientation and gender identity, and grant banking access to the marijuana industry, among other things.

(Passed 05/15/2020, 208 yeas to 199 nays, Roll Call No. 109)

5. Washington, D.C. Admission Act

Sponsored by Del. Eleanor Holmes Norton (D-DC), the *Washington, D.C. Admission Act* (H.R. 51) would admit Washington, D.C. as the 51st state. This measure is unconstitutional and does not reflect our Founders' intention for the federal seat of government to be independent of any one state in the Union. Furthermore, D.C.'s admission as a state would nullify congressional control over D.C.'s budget, effectively allowing D.C. to fund elective abortions and expand legal access to recreational marijuana.

(Passed 06/26/2020, 232 yeas to 180 nays, Roll Call No. 122)

6. State Health Care Premium Reduction Act

Sponsored by Rep. Angie Craig (D-MN), the *State Health Care Premium Reduction Act* (H.R. 1425) would dramatically increase subsidies for Obamacare health care programs without Hyde Amendment restrictions. This would provide billions of dollars in new taxpayer funding for abortion on demand through health insurance plans.

(Passed 06/29/2020, 234 yeas to 179 nays, Roll Call No. 124)

7. State, Foreign Operations, Agriculture, and Other Agencies Appropriations Act, 2021

Sponsored by Rep. Nita Lowey (D-NY), the *State, Foreign Operations, Agriculture, Rural Development, Interior, Environment, Military Construction, and Veterans Affairs Appropriations Act, 2021* (H.R. 7608) would undermine current pro-life policies. It would repeal President Trump's Protecting Life in Global Health Assistance Policy, which prohibits global health funds from paying for abortion. It would also weaken the Kemp-Kasten Amendment, which allows the president to withhold funds from organizations that promote coercive abortion policies.

(Passed 07/24/2020, 224 yeas to 189 nays, Roll Call No. 166)

8. Amendment to Prevent the Department of Justice from Enforcing Marijuana Laws

Offered by Rep. Earl Blumenauer (D-OR), this amendment (H.Amdt. 864) to the *Defense, Commerce, Justice, Science, Energy and Water Development, Financial Services and General Government, Labor, Health and Human Services, Education, Transportation, Housing, and Urban Development Appropriations Act* (H.R. 7617) would restrict the Department of Justice from enforcing the Controlled Substances Act in states and territories that have legalized recreational marijuana.

(Passed 07/30/2020, 254 yeas to 163 nays, Roll Call No. 174)

9. Defense, Commerce, Justice, Science, and Other Agencies Appropriations Act, 2021

Sponsored by Rep. Peter Visclosky (D-IN), the *Defense, Commerce, Justice, Science, Energy and Water Development, Financial Services and General Government, Labor, Health and Human Services, Education, Transportation, Housing, and Urban Development Appropriations Act* (H.R. 7617) would negatively impact many pro-life and pro-family policies. The bad provisions include blocking President Trump's Transgender Military Policy, *Protect Life Rule*, and *Conscience Protection Rule*, as well as giving special status to LGBT-identifying individuals and allowing D.C. to fund abortions.

(Passed 07/31/2020, 217 yeas to 197 nays, Roll Call No. 178)

10. Uyghur Forced Labor Prevention Act

Sponsored by Rep. Jim McGovern (D-MA), the *Uyghur Forced Labor Prevention Act* (H.R. 6210) would require companies to prove that goods produced in Xinjiang, China and imported to the U.S. are not made using forced labor of the Uyghur Muslim minority. It also calls on the U.S. secretary of state to develop a strategy for addressing forced labor in Xinjiang and impose targeted sanctions against individuals responsible for the forced labor program. This important international religious freedom measure sends a message to China's leaders that their human rights violations will cost them, and the U.S. will not participate in their human rights abuses.

11. Heroes Act 2.0

Sponsored by Rep. Mike Thompson (D-NY), the *House Amendment to the Senate Amendment to H.R. 925, or the Heroes Act*, is a coronavirus relief package that includes partisan language that undercuts life, marriage, and religious freedom. This bill would equate domestic partnerships to marriage in paid sick leave policies, exclude homeschool and religious school options in education funding, and increase banking access for the marijuana industry.

(Passed 10/1/2020, 214 yeas to 207 nays, Roll Call No. 214)

12. Resolution including Partisan Reproductive Choice Language

Sponsored by Rep. Pramila Jayapal (D-WA), this resolution condemns forced sterilization in response to reports that women at the Irwin County Detention Center in Georgia were given unwanted hysterectomies. However, it includes a clause that "recognizes that everyone deserves to control their own reproductive choices and make informed choices about their bodies," which is code for supporting elective abortion. H.Res. 1153, on account of including sweeping language that can be used to promote unlimited access to abortion, is not a serious attempt at securing bipartisan consensus on providing remedies for women who have undergone forced gynecological procedures.

13. Marijuana Opportunity Reinvestment and Expungement (MORE) Act

Sponsored by Rep. Jerry Nadler (D-NY), this bill would de-schedule marijuana from the Controlled Substances Act, making the drug fully legal at the federal level with no federal safeguards. It also includes language to dramatically increase investments into the marijuana industry.

(Passed 12/4/2020, 228 yeas to 164 nays, Roll Call No. 235)

14. Born-Alive Abortion Survivors Protection Act Discharge Petition

Filed by Rep. Steve Scalise (R-LA), this discharge petition would force a floor vote on the *Born-Alive Abortion Survivors Protection Act* (H.R. 982) if it gathered 218 signatures. This petition was filed due to House leadership failing to consider this important measure which would require health care practitioners to provide the same medical care to infants born alive after a failed abortion as they would to any other infant born at the same gestational age. This petition was open for the full length of the 116th Congress.

(Filed on 4/2/2019, this petition garnered 205 of the required 218 signatures)

15. Fairness for All Cosponsors

Sponsored by Rep. Chris Stewart (R-UT), *Fairness for All* (H.R. 5331), is billed as an alternative to the *Equality Act* that is supposed to solve protect religious liberty all the problems with legislation that promotes the LGBT agenda. Unfortunately, because jeopardizing religious liberty is not the only problem with the Equality Act, and other such legislation, this bill fails to acknowledge the full scope of the First Amendment or the problems with the Equality Act. Sponsorships for this bill were open for the full length of the 116th Congress.

(Introduced on 12/6/2019, this bill garnered 8 cosponsors)
